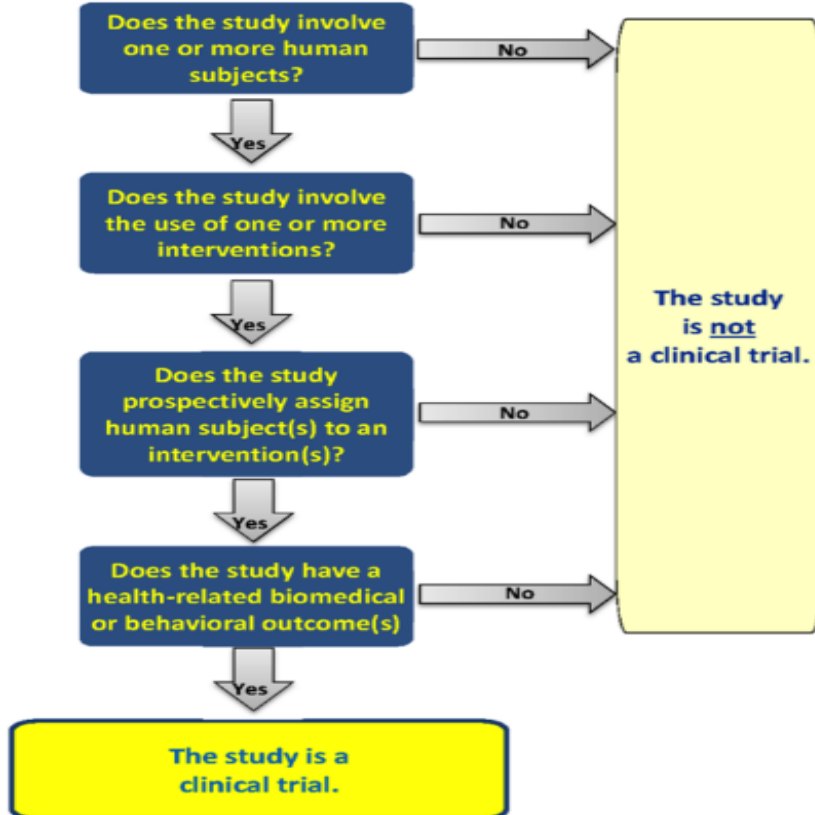
NIH R&R Forms E

- Required for **due dates on or after January 25, 2018**
- Consolidation of human subjects and inclusion enrollment report information into a **new PHS Human Subjects and Clinical Trials Information form**. The new form also **expands** clinical trial data collection to ensure the appropriate level of information for review and to improve oversight.
- **R&R Budget and associated R&R Subaward Attachment Form**
 - Added new “Total Costs and Fee” calculation to budget periods and cumulative budget

Clinical Trials- Definition



A “research study in which one or more human subjects are prospectively assigned to one or more interventions (which may include placebo or other control) to evaluate the effects of those interventions on health-related biomedical or behavioral outcomes.”

Clinical research includes all research involving human participants. It does not include secondary studies using existing biological specimens or data collected without identifiers or data that are publicly available. (<https://humansubjects.nih.gov/glossary>) Clinical trials are clinical research studies involving human participants assigned to an intervention in which the study is designed to evaluate the effect(s) of the intervention on the participant and the effect being evaluated is a health-related biomedical or behavioral outcome.
